3. Terms of Reference:

The Committee is entrusted to carry out the following activities:

- a. Monitor implementation progress of short, medium and long term reform recommendations as agreed in the Doing Business Reform Memorandum 2017 and subsequent Action plan;
- b. Provide guidance to the reform implementing agencies in removing any challenges faced during implementation;
- c. Encourage the reform implementing agencies to adopt doing business reform targets in respective Annual Performance Agreement (APA) and other institutional performance matrices;
- d. Recommend for any resource allocation to support better capacities for reform adoption and implementation; and
- e. Undertake any relevant activities required to expedite implementation of doing business reforms;

4. Meetings and Secretarial Support:


- a. The Committee will meet as and when necessary.
- b. The Doing Business Reform Coordination Secretariat (DBRCS) of Bangladesh Investment Development Authority(BIDA) will provide secretarial support to the committee.
- c. The Committee may ask DBRCS to deploy necessary technology/system to track progress of reform implementation.

5. Duration and effect:

The committee will be permanent and continue its works to achieve Bangladesh's rank in the World Bank Doing Business index to a double digit position.
